Graham Thompson was 2nd in the divisional Championships for a Tinner.

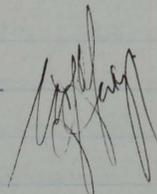

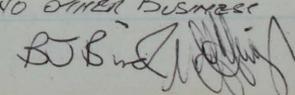

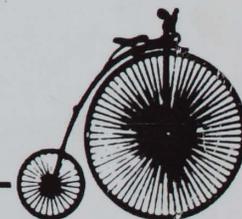
